

Camps/Programs Terms and Conditions

Summer Camp/ Seasonal Camps

Refunds/Cancellation

Requests for cancellation and refunds must be submitted in writing to NTCprograms@usta.com and received 10 days in advance of the first date of the NTC Summer Camp season in June. No refunds for cancellation requests will be considered after the start of the NTC summer camp session. All individual cancellations/changes made in advance of the NTC Camp start date will incur a \$50 administrative fee. **No make ups for any missed days or weeks for Camp.** Summer camp field trips must be registered on separate registration form and signed by parent and/or legal guardian. **Seasonal camps:** please refer to the cancellation policy that is listed on the appropriate seasonal camp flyer.

Adult and Junior Tennis Programs

Cancellation Policy

All program cancellations must be submitted in writing NTCprograms@usta.com and received by the Programs Office at least 10 days prior to start of class per session to be considered for a refund/credit. There will be no refunds/credits after the program start date. All individual program cancellations or changes will incur a \$50 administrative fee. Checks returned by the bank will incur a \$30 fee and must be replaced with cash or money order.

Make-up Policy for Programs

Notice of a student's absence must be given to the NTC Programs office at least one (1) day, 24 hours, in advance of the absence. This student will be offered participation in one (1) clinic offered during or at the end of the current session in lieu of an in-class make up (limited to 1), free of charge. Please note that we do not offer in-class make ups, credits, refunds, carryovers for missed classes, no shows, or same day cancellations.

Clinic dates are posted on session flyers and online at NTC.USTA.com.
